

## **Protect Our Winters Strava: Solstice Sweepstakes Official Sweepstakes Rules and Legal Disclaimer**

**NO PURCHASE, DONATION, OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE, DONATION OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.**

### **Introduction**

By entering the Protect Our Winters Strava: Solstice Sweepstakes (the “Sweepstakes”), participant (the “Participant”) agrees to abide by these Official Sweepstakes Rules and Legal Disclaimer and the decision of Protect Our Winters (“POW”), which are final and binding in all respects.

### **Eligibility**

The Sweepstakes is open to (i) (a) all legal residents of the fifty United States, the District of Columbia and Puerto Rico and (b) all legal residents of countries where this Sweepstakes is not void, who (ii) are at least 18 years old or the age of majority in your country of legal residency (whichever is greater), at the time of entry. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law. Void in Afghanistan, Belize, Belarus, Bolivia, Bosnia and Herzegovina, Burma, Cambodia, Chad, China, Colombia, Croatia, Cuba, Eritrea, Hungary, India, Ireland, Iran, Iraq, Italy, Kosovo, Latvia, Lebanon, Libya, Lithuania, Luxembourg, Macedonia, Montenegro, Myanmar, North Korea, Pakistan, Poland, Portugal, Republika Srpska, Romania, Serbia, Singapore, Somalia, Spain, Sudan, Sweden, Syria, Tanzania, Thailand, Turkey, and Venezuela. Void in countries subject to U.S. export control restrictions and sanctions, countries embargoed by the U.S., and countries that have been designated by the U.S. government as ‘terrorist supporting’ nations.

### **Sponsorship**

This Sweepstakes is sponsored by Protect Our Winters (“Sponsor”), located at Niche Workspace, Attn: Protect Our Winters, 4571 Broadway St, Boulder, CO 80304. Sponsor and its respective affiliates, subsidiaries, successors, assigns, agents, representatives, officers, directors, shareholders and employees (including the immediate family members of such employees and/or those living in the same household of each such employees), and any entity involved in the development, production, implementation, administration, judging or fulfillment of the Sweepstakes, are not eligible to participate. Sponsor will conduct Sweepstakes substantially as described in these Official Rules.

### **Entry Period**

This Sweepstakes begins on Thursday, June 20th, 2024, at 12:01 AM Mountain Daylight Time (UTC/CMT -6 hours) and ends on July 10th, 2024, at 11:59 PM Mountain Daylight Time (UTC/CMT -6 hours) (“Entry Period”).

### **How to Enter**

a. A Participant is entered by completing the Strava challenge within the Strava application, which will then forward them to a POW landing page where they will have instructions on how to enter. A Participant enters by filling out the corresponding personal contact information to the corresponding country form.

b. Alternative Method of Free Entry without Survey Submission. No purchase, donation, or payment of any kind is necessary to enter or win this Sweepstakes. A purchase, donation, or payment will not increase an entrant's chance of winning. To be automatically entered into the Sweepstakes via an alternative method of free entry, you may request an entry form from [info@protectourwinters.com](mailto:info@protectourwinters.com) and mail your entry to Niche Workspace, Attn: Protect Our Winters, 4571 Broadway St, Boulder, CO 80304. All entries must be received before the end of the Entry Period in order to be considered for the drawing.

### **Entries**

Limit of one (1) entry per eligible user during the Entry Period. Entries using macro, robotic, scrip or other forms of automatic entry will be disqualified. Proof of submission does not constitute proof of receipt. Sponsor is not responsible for late, incomplete, or inaccurate entries. If there is a dispute as to the identity of an online entrant, the prize will be awarded to the authorized account holder of the e-mail address. The "authorized account holder" is defined as the natural person to whom the email address is assigned by an Internet service provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

### **Grand Prize**

Six (6) Prize Winners will be selected and will be awarded, after confirmation of eligibility, one (1) of six (6) Prize packs. Prize packs include a POW hoodie, hat and sticker, Skullcandy headphones, Doma X POW coffee bag, and Sanuk X POW shoes. (together, the "Prize"). Approximate retail value of \$440 (USD). Winner(s) is responsible for any international, federal, state and local taxes. Prize is non-transferrable, not redeemable for cash and not exchangeable for any other prize. Sponsor will not replace any lost or stolen prize items. No prizes are won simply by entering.

### **Taxes**

Any valuation of the prize(s) stated above is based on available information and the value of any prize awarded to a winner may be reported to the Internal Revenue Service, or to the applicable authorities in your jurisdiction for tax purposes as required by law. The Drawing will be conducted by the Sponsor, whose decisions and interpretations on all matters relating to the Sweepstakes and these Official Rules are final and binding in all respects. Sponsor reserves the right to disqualify any entrant or winner and may refuse to award a prize to a person who is not eligible or has violated a rule, gained unfair advantage in the Sweepstakes or obtained winner status using fraudulent means. If there is a dispute about the identity of an entrant, the Prize will be awarded to the natural person to whom the email address is assigned by the internet service provider responsible for the domain associated with the submitted email address. Winner will be notified by email.
