

Protect Our Winters Vote Tripling: Stoke The Vote Sweepstakes Official Contest Rules and Legal Disclaimer

Introduction

By entering the Protect Our Winters Vote Tripling: Stoke The Vote Sweepstakes (the "Contest"), participant (the "Participant") agrees to abide by these Official Contest Rules and Legal Disclaimer and the decision of Protect Our Winters ("POW"), which are final and binding in all respects.

Eligibility

The Contest is open to (i) all legal residents of the 50 United States and the District of Columbia, who are at least 18 years old at the time of entry. The Contest is void outside the U.S., in Puerto Rico, the U.S. Virgin Islands, and other U.S. territories and possessions. The Contest is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law.

Sponsorship

Sponsor will conduct Sweepstakes substantially as described in these Official Rules.

Entry Period

This Sweepstakes begins on October 1, 2024, at 12:01 AM MT and ends on November 5, 2024, at 11:59 PM MT ("Entry Period").

How to Enter

- a. A contestant is entered by completing the Vote Tripling Phone 2 Action questionnaire within the stokethevote.org landing page. By entering information into this form a contestant will be entered in the Contest .
- b. Alternative Method of Free Entry without Survey Submission. No purchase, donation, or payment of any kind is necessary to enter or win this Sweepstakes. A purchase, donation, or payment will not increase an entrant's chance of winning. Boulder, CO 80302. All entries must be received before the end of the Entry Period in order to be considered for the Drawing.

Entries

Limit of one (1) entry per eligible user during the Entry Period. Entries using macro, robotic, scrip or other forms of automatic entry will be disqualified. Proof of submission does not constitute proof of receipt. Sponsor is not responsible for late, incomplete, or inaccurate entries. If there is a dispute as to the identity of an online entrant, the prize will be awarded to the authorized account holder of the e-mail address.
